1. *The Government of Nepal has allocated funds towards the cost of Construction of Kalche-Thulitar-Badalgaun Road at Dhulikhel Municipality-Ward No. 08, 09 and 11 and intends to apply part of the funds to cover eligible payments under the Contract for DMO/NCB/IS2E/WORKS/2083/84/04(RE). Bidding is open to all eligible as per Section V of bidding document.*
2. *Dhulikhel Municipality, Kavrepalanchok invites electronic bids from eligible bidders for the Construction of Kalche-Thulitar-Badalgaun Road at Dhulikhel Municipality-Ward No. 08, 09 and 11 under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.*

Only eligible bidders with the following key qualifications should participate in this bidding:

- Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: **NRs. 3,65,58,000 (Three crore sixty-five lakh fifty-eight thousand rupees only)**
 - Minimum Work experience of similar size and nature: Participation as Prime contractor, management contractor, or subcontractor, within the last ten (10) years with a value of at least **NRs. 1,38,11,000 (One crore thirty-eight lakh eleven thousand rupees only)**, that have been successfully or are substantially completed and that are similar to the proposed works.
3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.

7. Sealed bids must be submitted to the office of *Dhulikhel Municipality, Kavrepalanchok* through PPMO's e-GP system www.bolpatra.gov.np/egp on or before **12:00 hrs** on **2083/06/27.**

Bids received after this deadline will be rejected.

8. The bids will be opened in the presence of Bidders' representatives who choose to attend at **2083/06/27 at 13:00 hrs** at the office of **Dhulikhel Municipality, Kavrepalanchok**. Bids must be valid for a period of **90 days** from the bid submission deadline and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs. **8,63,200** which shall be valid for 30 days beyond the validity period of the bid ((2083/10/26).
9. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
